



## Yadkin Valley Harvest Festival Non-Food Vendor Regulations

Thank you for your interest in our festival. The following information will help you with the application process. If you are new to our festival, you can anticipate 5,000+ spectators. There is no admission fee for spectators.

**APPLICATION DEADLINES:** The deadline for non-food vendor applications is **August 1st** but please note that spaces may fill up before this deadline. Applications received after that date will incur a **\$25 late fee**.

**BOOTH SPACE:** Booth spaces are a generous 15' x 10' (width x depth). This allows walk space between each booth space so your customers can have access on three sides of your tent. **All vendor tents must be appropriately weighted down.** No tables, chairs, electrical cords, etc. will be provided. You must have your booth set up and ready to do business by 9:30 a.m. and all vehicles must be clear of the booth area by 9:00 a.m. **All trash is to be removed by vendors to designated containers at the close of the festival.**

**UNLOADING:** Unload your vehicle at your space and immediately park your vehicle in a designated lot. You may then return to your booth for set up. **DO NOT** leave your vehicle parked in the street while you set up as this blocks other vendors from being able to unload.

**FESTIVAL HOURS:** The Yadkin Valley Harvest Festival operates from 10:00 a.m. to 3:30 p.m. All vendors are required to stay open for the duration of the festival. Due to safety concerns, streets will be closed to vehicle traffic from 9:00 a.m. to 4:00 p.m.

**SETUP TIMES:** Typical set-up time starts at 6 a.m. Saturday morning. We will send out an email the week of the festival with definite instructions.

**BOOTH ASSIGNMENTS:** Will be emailed the **week of the festival** along with any last minute information. **If you do not have an email address, make sure you provide a phone number with your application so that we can call and give you your booth information.**

**ELECTRICITY/GENERATORS:** Because of limited availability in our downtown footprint we no longer guarantee electricity for any of our vendors. If you need electricity please call us before you register and we can let you know your options are. The use of a generator must be approved by the Yadkin Arts Council in advance to the festival. If you plan to use a generator, please call in advance of completing the registration for your booth. We will only approve the use of a generator if the vendor can guarantee that it will not disrupt their fellow vendors. **Approval will go to vendors with “Quiet” Generators ONLY.**

**WEATHER POLICY:** This event occurs rain or shine. The festival sponsor cannot make refunds in case of rain OR be responsible for accidents, damages or other loss incurred by vendors. Compliance with applicable state or federal laws (e.g. collection of sales tax) is the responsibility of the vendor. **Submission of an application is an implied agreement to abide by the rules set forth herein.**
